Highlights of the CAT4 Test:

- 1. An assessment of reasoning ability to identify where a pupil's real strengths lie, free from the constraint of the curriculum and not held down by any learning barriers.
- 2. The Cognitive Abilities Test: Fourth Edition (CAT4) provides a robust, standardized measure of cognitive reasoning ability, without reference to curriculum-based material and regardless of previous achievements or first language.
- 3. Invaluable insight into pupils' ability to reason across **four distinct batteries**: verbal, non-verbal, mathematical and spatial.
- 4. Upon Administration of CAT4, a range of reports can be automatically generated. The data could be presented in visually accessible tables, bar charts and scatter graphs that allow for easy comparison, as well as clear narrative explanations that explain the pupil profile and its implications for teaching and learning outcomes.
- 5. Combined Reporting of the results of other assessments is enabled. Ability to identify pupils who could be achieving more. Ability to drill down into anomalies and put early intervention strategies in place.
