Sub: Schedule for Conjugate Meningococcal & Tdap Vaccine

As informed earlier via Circular No. SIS/061/2020-2021 dated 23rd September we will be giving the following vaccines to the the students of Grade XI:

1. Conjugate Meningococcal Vaccine
2. Tdap Vaccine

The vaccination will be given to your ward as per the schedule given below. You are requested to accompany your ward and follow the given schedule and Covid-19 protocol strictly. Only the students who have submitted the consent form will be given vaccination.

Kindly note the following:

- Students are required to bring their Emirates ID and the original vaccination card or a copy along with them.
- School transport will not be available for the students. Since it is vaccination, one of the parent is required to accompany your ward to school. Parents will not be allowed to enter the vaccination room. The respective Grades will not have regular classes on the scheduled dates allotted to them.
- Please make sure that your ward takes proper breakfast before coming for the vaccination.
- All are required to wear mask and gloves before entering the school campus.
- Vaccination will not be given to the students with fever, cough, running nose, cold or under antibiotic medication.
- Please stay in the waiting area for 15 minutes once the vaccination is done before leaving the campus.
- Please make sure that your ward has not taken any other vaccination during the previous 4 weeks.
- If your ward is under any medication (homeopathy or allopathy) then she will be required to stop the medicines 5 days prior to the vaccination date.
- If the child is under any medical treatment (e.g. asthma, epilepsy etc), parent is required to produce the medical file.
- Students who have taken Meningococcal Vaccine (umrah vaccine) in the previous 5 years need not take the same again. However the Tdap vaccine will be given to these students.
